FACILITY UNCW Natatorium, Wilmington, NC The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming. The competition pool is an 8-lane 25-yard pool with non-turbulent lane lines(7 ft. width) water depth at both ends is 4.5-5.5 feet. Colorado electric timing, scoreboard, and fixed starting blocks. There is an additional 5-lane 20 yard pool for continuous warm up and warm down.

- **SAFETY** The NCS Safety Program is in effect for this meet. Coaches are advised to closely supervise their swimmers at all times. NO running or horseplay will be tolerated.
- **RACING STARTS** Any swimmer entered in the meet, unaccompanied by an USA Swimming member coach, must be certified by an USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmerges legal guardian to ensure compliance with this requirement.
- **RULES**This meet will be conducted in accordance with the current USA Swimming
Rules and Regulations, except where rules therein are optional and exceptions
are stated.
Use of audio or visual recording devices, including a cell phone, is not
permitted in changing areas, rest rooms or locker rooms.
Deck changes are prohibited.
- **ELIGIBILITY** All swimmers must be registered with USA Swimming, Inc. Swimmers must be registered prior to entry deadline. Entries listed as õRegistration Applied Forö will not be accepted. There will be no on deck registration available at this meet.
- **SWIMMERS WITH DISABILITIES** Waves of Wilmington welcomes all swimmers with disabilities as described in the USA Swimming Rules and Regulations, Article 105, to participate in our meets. Coaches entering swimmers with disabilities that require any accommodations are required to provide advance notice in writing to the Meet Director by the entry deadline accompanying their meet entry file, including the need for any personal assistants required and/or registered service animals. Failure to provide advance notice may limit Waves of Wilmingtonøs ability to accommodate all requests.
- **ENTRIES** Entries submitted in Hy-tek format require no hard copy entry forms. Email is preferred for electronic entries. Payment in full must be received by the Meet Entry Coordinator by the start of the meet. A swimmerøs age on the first day of the meet will determine their age for the entire meet. Waves of Wilmington entries will be entered first and then accept teams/entries in the order received, until the four/eight hour rule is reached. Entries received thereafter will be returned immediately. All relay only swimmers including alternates must be listed and pay the NCS Travel Fund surcharge.

ENTRY LIMITATIONS	13 & Over swimmers may enter 3 individual events per day.12 & Under swimmer may enter up to 4 individual events per day.
	The 400 IM and 500 Free will be positive check-in events and may be limited to the top 24 swimmers for both women and men (based on timeline constraints). These events will be swum fastest to slowest alternating women and men. The referee will have the authority to combine the slowest two heats if needed.
ENTRY VERIFICATION	An email will be sent to the person submitting the entry confirming receipt of the entry within 48 hours of receipt.
ENTRY DEADLINES	Meet entries open on Tuesday, September 20 at 9:00 AM and close on Tuesday, October 4 at 11:59 PM. Late entries may be accepted at the discretion of the Meet Referee and will be charged double entry fees. There will be no on deck entries.

SEEDING	The conforming time standard for this meet is short course yards. Swimmers will be seeded and swim from slowest to fastest in all timed final events. All non-conforming times will be seeded last in rank order. The 500 freestyles and 400 IM may be limited to the top 24 swimmers in each event (based on timeline constraints).
CHECK-IN	A positive check-in, located at the admin table, will be required for the following events: i 13 & Older 500 free i 13 & Older 400 IM Check in for event will be as stated in the Deadline and Meeting Summary.
SCRATCHES	There will be no penalty for scratching events at the block.
