FACILITY

The Greensboro Aquatic Center is a state-of-the-art indoor facility with three pools which opened in August 2011. The main competition pool is 9-10 feet deep at both ends and will be configured into one 50 meter yard courses with up to eight 9-foot wide lanes each. All lanes feature non-turbulent lane lines and Paragon KDI starting blocks. Up to eight lanes will be used for this competition. The Omega electronic timing system will be used. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming. At least three lanes will be open for continuous warm up and down. Seating for 1800 spectators is available. The Greensboro Coliseum will provide free parking. Directions to the GAC are available at www.GreensboroAquaticCenter.com.

MEET FORMAT

This is a closed time trial pre-seeded/deck seeded meet.

ELIGIBILITY

These ACC LC Time Trials are open to any member of an ACC Men's and Women's Swimming team who is eligible to represent his/her school in NCAA competition in the 2018-2019 season. Both sessions are open to men and women.

The results of these LC Time Trials will NOT be uploaded to the NCAA database and will NOT be considered for NCAA Championship meet qualification.

Swimmers who are also 2019 registered members of USA Swimming and are registered through their respective LSCs prior to February 15, 2019 will have

their results automatically uploaded to SWIMS for USA Swimming meet qualification. **No on deck registration is available at either meet.**

RULES

This meet will be conducted in accordance with the current USA Swimming Rules and Regulations, except where rules therein are optional and exceptions are stated.

ENTRIES

Entry files for each session may be emailed to the Entry Coordinator until the stated deadlines.

On deck entries will be accepted during regular TT sign up hours at both Championship meets and on the mornings of each TT session.

Entries should be made with LCM or SCY times. Times are not required to be provable and may be estimated to provide accurate seeding for all competitors. NT entries will be seeded last.

ENTRY DEADLINES

Entries may be submitted via Hytek email up until midnight on Tuesday, Feb. 19 for the February 24 session and until midnight on Tuesday, Feb. 26 for the March 3 session.

On deck entries will be accepted from 7:00 AM to 9:00 AM on each morning. Entries made after this time will be considered late and accepted only for open lanes and at the discretion of the Meet Referee.

ENTRY LIMITATIONS Swimmers may swim a maximum of six (6) time trials per session. Breaks may be scheduled by the Meet Referee and will be announced in the coaches' meetings.

ENTRY FEES

No fees will be charged for these sessions.

ENTRY VERIFICATION

Preliminary psych sheets for each session will be posted at GAC and on www.GreensboroAquaticCenter.com.

SEEDING

The conforming time standard for this meet is long course meters. Swimmers will be seeded slowest to fastest, LCM then SCY. The Meet Referee reserves the right to combine heats and events according to USA Swimming rules.

Swimmers should positively check in for their events by 8:30 AM at each session to be seeded.

SCRATCHES

There is no penalty for scratching events at the blocks.

WARM-UP

General warm up in all lanes from 8:30-9:10 AM. Specific warm ups from 9:10-9:25 as follows: one-way dive starts in Lanes 2 and 7, pace in Lanes 1 and 8, general warm up in other lanes. Additional sprint and pace lanes may be assigned or opened early at the Meet Referee's discretion. The Marshal will ensure teams, coaches, and swimmers follow all warm-up procedures.

During the competition, there will be at least three lanes available for continuous warm-up/down. Swimmers will enter the pool feet first in this area.

SAFE SPORT

The NCS Safety Program is in effect for this meet. Coaches are advised to closely supervise their swimmers at all times. Swimmers may be dropped off only in designated safe areas. Swimmers are not permitted in work out rooms, storage rooms, meeting rooms, or control rooms. No glass containers or bottles are allowed inside the facility at any time. Anyone failing to comply with a safety request may forfeit his or her privilege to participate. We strongly recommend each team assign a marshal to monitor warm-up sessions in addition to host team marshal.

Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, rest rooms or locker rooms.

DECK CHANGES ARE PROHIBITED.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Only swimmers, properly certified officials and coaches, and meet volunteers will be allowed on deck. No spectators will be allowed on deck at any time.

Any swimmer entered in the meet, unaccompanied by a USA Swimming/NCAA member coach, must be certified by a USA Swimming/NCAA member coach as being proficient in performing a racing start or must start each race from within

the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

SCORING/AWARDS

These sessions will not be scored and no awards will be made.

RESULTS

Results will be posted on GAC's website (<u>www.GreensboroAquaticCenter.com</u>) within 24 hours of each meet's conclusion and teams will be emailed their results.

SWIMMERS WITH DISABILITIES

WOLF-NC welcomes all ACC swimmers with disabilities as described in the USA Swimming Rules and Regulations, Article 105, to participate in the meets. Coaches entering swimmers with disabilities that require any accommodations are required to provide advance notice in writing to the Meet Director by the entry deadline accompanying their meet entry file, including the need for any personal assistants required and/or registered service animals. Failure to provide advance notice may limit WOLF-NC's ability to accommodate all requests.

COACHES

All coaches on deck must be registered and properly certified with their ACC teams and must check in with the Meet Director.

There may be a General Meeting each morning at 9:20 AM at the Meet Referee's discretion. Other meetings may be held at the Meet Referee's discretion. Meet Management requests that at least one coach representative from each team attend all coaches' meetings. Coaches are responsible for any information presented at the meeting.

OFFICIALS

All ACC Championship officials are encouraged and welcome to officiate at these time trials. Contact the Meet Referee by email prior to the meet. Other officials may be invited to assist. Officials briefings will be held 45 minutes prior to the start of the session in the hospitality area.

Uniform for these meets is white polo over **KHAKI** or **NAVY** pants, shorts, or skirts with white shoes.

HOSPITALITY/ CONCESSIONS

There will be limited hospitality available on deck to all coaches and officials. Refreshments will be for sale at concession stands. Outside food beyond that needed for swimmer nutrition and hydration is not permitted by the facility.

IMAGE RELEASE

All participants agree to be filmed and photographed by the NCS approved photographer(s) and videographers and to allow the right to use names and pictures before, during, or after the meet such as in public psych sheets, heat sheets, and results or featured on the NCS website or in public broadcast of the event via television or webcast. Parents and guardians of minor swimmers who do not wish their swimmers to participate in interviews or have individual pictures featured on any media should inform their team's head coach and the Meet Director prior to the meet.
