NCS FACE COVERING STATEMENT and FACILITY REGULATIONS

NCS recommends the proper use of face coverings at all NCS activities and expects all participants, coaches, officials, volunteers, and spectators to comply with all club and facility specific COVID-19 safety requirements and guidelines from USA Swimming, North Carolina Swimming, the State of North Carolina, and local jurisdictions. Compliance with the guidelines in place at the time of the meet will be maintained throughout the duration of the meet.

A determination regarding spectators in the facility will be made prior to the start of the meet and will be based on number of athletes entered and any facility restrictions imposed at the time of the meet. Spectators, if permitted, may be limited and/or may be denied entry or reentry if maximum facility capacity is reached. All spectators must remain in the designated seating areas along the Lane 8 side of the pool at all times. Only athletes, coaches, officials, and pre-authorized volunteers will be allowed on deck (including the bleachers at the start/turn ends or the Lane 1 side of the pool). Parents needing access to their athlete during the meet in a closed-deck environment can contact their children directly via cellphone and arrange to meet in the main lobby. Should parents be unable to contact their child directly, they should ask the front desk to see the Meet Marshal. In case of an emergency, please contact the Meet Director.

FACILITY

The competition pool is a 50-meter pool with 2 bulkheads. Minimum depth is 6 feet at the scoreboard end and 13 feet at the diving board end. The pool is equipped with eight, 9-foot-wide lanes with non-turbulent lane lines and Paragon starting blocks which will be used for competition in accordance with USA Swimming diving depth guidelines. Colorado 6000 electronic/automatic timing system with a scoreboard will be utilized with touchpads and two (2) timers per lane each operating a watch and button. Hy-Tek Meet Manager software will be used. The warm pool will be available for continuous warm up and warm down. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming. Parking is available in several lots across the street from the facility. Spectator parking is not allowed in the main lot. Smoking is not permitted inside the building. Absolutely no glass bottles will be allowed on the pool deck. Only meet volunteers, USA Swimming registered athletes and current USA Swimming registered officials and coaches may be on deck.

MEET FORMATThis is a timed final, pre-seeded meet for 12 & Under events. 13 & Over events will be
Prelims/Finals with a B final followed by an A Final unless otherwise indicated. All Friday events
will be timed finals. Breaks may be scheduled or adjusted at the discretion of the Meet Referee
based on entries and timeline considerations. Further, the Meet Referee has the authority to
add or combine sessions, adjust start times, change session, events or make any other changes
necessary to improve competition or comply with current safety guidelines/restrictions.

SAFETY	The NCS Safety Program is in effect for this meet. Coaches are advised to closely supervise their swimmers. NO running or horseplay will be tolerated
RACING STARTS	Any swimmer entered in the meet, unaccompanied by an USA Swimming member coach, must be certified by an USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
RULES	This meet will be conducted in accordance with the current USA Swimming Rules and Regulations, except where rules therein are optional, and exceptions are stated. A modified Scratch rule will be utilized for this meet. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms. Deck changes are prohibited. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.
Technical Suit Ban for 12 & Unders	Per USA Swimming Rule 102.8.1F, 12 & Under athletes may not compete in Technical Suits at this meet.
	 A Technical Suit is one that has the following components: Any male or female suit with bonded or taped seams regardless of fabric or silhouette; or Any male or female suit with woven fabric extending to the knee or mid-thigh regardless of the seam type
МААРР	All applicable adults participating in or associated with the meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Protection Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.
ELIGIBILITY	All swimmers must be registered with USA Swimming, Inc. Swimmers must be registered prior to entry deadline. Entries listed as "Registration Applied For" will not be accepted. There will be no on deck registration available at this meet. Include any minimum/maximum time standards for qualification to enter the event, team affiliations, etc.
SWIMMERS WITH DISABILITIES	Sailfish Aquatics welcomes all swimmers with disabilities as described in the USA Swimming Rules and Regulations, Article 105, to participate in our meets. Coaches entering swimmers with disabilities that require any accommodations are required to provide advance notice in writing to the Meet Director by the entry deadline accompanying their meet entry file, including the need for any personal assistants required and/or registered service animals. Failure to provide advance notice may limit Sailfish Aquatics' ability to accommodate all requests.
ENTRIES	Please email entries using Hy-Tek Team Manager format files. List all swimmer's ages as of July 29, 2022. Sailfish Aquatics reserves the right to limit entries for each team. All relay only swimmers including alternates must be listed and pay the NCS Travel Fund surcharge.
ENTRY LIMITATIONS	12&under swimmers are limited to a maximum of 4 individual events per day and 10 individual events throughout the meet. 13&over swimmers are limited to a maximum of 3 individual events per day and 8 individual events for throughout the meet. Required provable entry times for the 10&under events: 200 Free - Girls 4:00.00, Boys 3:45.00 200 IM - Girls 4:00.00, Boys 4:00.00.

SEED		The conforming time standard for this meet is long course meters. Swimmers will be seeded and swim from slowest to fastest unless otherwise indicated. All non-conforming times will be seeded last in rank order. There will be no course conversion for this meet. The 400 IM and 400 Free will be deck seeded slowest to fastest. No Time (NT) will not be accepted for entries in these events, entries may be limited to stay within the allotted time. For "NT" athletes only, please enter with an estimated/approximate time.	
CHEO	CK-IN	Positive check in will be required for the 400 IM and 400 Free. See meet meeting and deadline section for deadlines for positive check in. Swimmers failing to check in will not be guaranteed a lane assignment. Swimmers failing to compete in an event they are positively checked in to may be penalized their next individual event.	
SCRA	TCHES	A modified scratch rule will be used. Swimmers in announced A or B finals, must either scratch or declare their intent to scratch within 30 minutes of announcement. If a swimmer declares intent and does not return to scratch, they will be seeded in the final event. A swimmer who then fails to compete in said final, shall be barred from his/her next individual event. The Meet Referee may waive this penalty at their discretion. Swimmers are requested to scratch their events regardless of place if they are not returning for Finals.

OFFICIALS/TIMERS/ VOLUNTEERS	There will be a need for officials. Sailfish Aquatics welcomes and encourages anyone willing to volunteer to contact the Meet Referee by email prior to the meet or sign in once you arrive at the meet. All officials on deck must be registered and certified with USA Swimming and will be required to show proof of such to the meet referee by displaying their registration card or be prepared to show their Deck Pass virtual membership card upon request. A certification card showing the official's level of certification must also be presented. Any official's assistance will be greatly appreciated and will help to ensure a great meet for the swimmers. Official briefings will be provided with a meeting schedule prior to the meet, or 30 minutes prior to each session
HOSPITALITY/ CONCESSIONS	There will be a hospitality area open to all coaches and officials. Refreshments may be available at the concession stand.
WARM-UP	In accordance with USA Swimming guidelines, there will be a published warm-up procedure for all swimmers and coaches attending the meet. The Marshall will ensure all teams, coaches, and swimmers follow all warm-up procedures. Meet Management reserves the right to change warm-up times according to the number of entries. During the competition, there will be lanes available for continuous warm-up/down. There is to be no diving or horseplay in this area.
WAIVER/RELEASE	As a team entered in this meet, upon entry you are verifying that all of the swimmers and coaches listed on the enclosed entry are registered with USA Swimming. You acknowledge that you are familiar with the Safety Rules of USA Swimming, Inc. and North Carolina Swimming, Inc. regarding warm- up procedures and meet safety guidelines, and that you shall be responsible for the compliance of your swimmers with those rules during this meet. Sailfish Aquatics, Mecklenburg County Aquatic Center, North Carolina Swimming, Inc., and USA Swimming, Inc., their agents, employees, and coaches shall be held free and harmless from any and all liabilities or claims for damages arising by reason of illness or injury to anyone during the conduct of this meet.
