#### Officer Reports –

- Financial- Our Balance sheets look good. The Wells Fargo account is up 9.8% for the year. Profit-loss also looks good. Everyone has done a great job following the budget. Well done!
- The 2021-22 budget is projecting a 13K profit at year end. The budget reflects a new camp for 11-14 swimmers. Other factors regarding the budget include that we will be attending zone workshops rather than the annual convention as well as changes with the open water zone team.

#### **BUSINESS MEETING:**

##### Review of Current Financial Situation (Budget 2021-22)

- The 2021-22 budget is projecting a 13K profit at year end. The budget reflects a new camp for 11-14 swimmers. Other factors regarding the budget include that we will be attending zone workshops rather than the annual convention as well as changes with the open water zone team.

##### Review of the USA Swimming Annual Business Meeting

- What passed?
  - New HOD structure. The legislation includes a new task force that will oversee and review over the next 2 years to determine direction
  - LSC's will have a different delegation that will include 3 coach members and 1 non-athlete member.

- The USOPC requires that we name our delegates by Dec. 3, 2021. We will name our delegates to comply and will then recommend changes to the by-laws at Spring 2022 HOD
- Going forward Zone workshops will take the place of the annual convention.
- Convention will become an annual "business" meeting
- USOPC is expanding the scope of adults who need to be USA Swimming members. They are working on the definitions as well as the fee for membership
- 3 proposals were made regarding Age Group Developmental meets. Generally the issue is attracting new (younger) athletes to the sport.
  - Meets will include 25 yard/scm events (PASSED)
  - Meets will require a minimal number of officials (PASSED)
  - LSC's can opt IN or OUT of developmental meets
- All non-athletes will (once again) receive a USA Swimming rule book
- Swim-offs can now be resolved with "creative" options (rock, paper scissors, anyone?)
- 2 self-nominated candidates were elected to the board (Ira Klein, Clark Hammond)
