## Officer Reports -

- Financial Financials look good. NCS has moved to reporting on a quarterly basis, First quarter financials will be reported at the next board meeting.
- SSRP 38 out of 77 teams in NCS are Safe Sport recognized, while 9 teams are applying/renewing. There are teams that have more than 41 points, need to apply. NCS is 3<sup>rd</sup> in the country for number of teams that are SSRP recognized. In the future teams will be required to be SSRP to be eligible to host a meet.
- Governance New committee chairs are being identified work in process.
  Succession planning for committee member and board members will be discussed at future board meetings.
- Legislative changes to National Selection process discussed. Legislative committee will make the decision where the selection process will be updated, possibly as a by-law change. Process will be presented in April 2022 at NCS HOD; and will be presented to USA Swimming via NCS by-laws. Discussion on how NCS may consider to allocate one coach slot as a YMCA coach slot. Concern shared that the YMCA use to have delegate slots to convention and had a vote. That is no longer the case as affiliate members have lost their vote. Suggestion that NCS could show support for YMCA by making 1 coach delegate as a YMCA seat.

Adoption of minutes and officer reports – prior minutes will be sent out in the coming days with all comments due to secretary by November 30.
