## **BUSINESS MEETING**

- Triston talked about a Women in Coaching event being developed by the Coaches Committee. The event is tentatively scheduled to occur in Asheville for January 31- Feb 2,2025. Triston will discuss the event more with the committee and bring back a proposal at the January meeting.
- AG Champs Spectator Control Melissa Oman, Director of Operations from TAC joined the discussion to talk about some proposed actions to manage spectators at the 2025 Age Group Champs Short Course meet to be held at the Triangle Aquatic Center. Initial discussions have taken place between TAC and Amy Faulk regarding the 12 and under sessions timed final sessions for Friday, Saturday and Sunday. There are no plans for spectator control for the preliminary or final sessions or the timed final session on Thursday. TAC can handle approximately 1000 spectators at any one time. Overflow is proposed to be in a heated tent outside with a streaming video. There was an extensive discussion of the possible use of bands for parents. No final agreement was made with concerns coming from some coaches. A work group to include coaches, officials, athlete representative, and NCS swimming will be convened to finalize details.
- Jamie Bloom reported Queens University has been secured for DEI Camp on April 12, 2025. Jamie will be working on the schedule. The next Southern Zone meeting will be in December. The plan is to target International Water Safety Day in May with more details to follow.
- Rob Stevens reported the first Junior Official has been certified and more are moving through the apprenticeship program. Linda Hughes stepped down as the Zone 2 Officials Representative and Tammy Schmidt from MOR has been chosen to replace her. There will be ten officials qualifying meets over the next few months. All of the Meet

- Referees have been selected for the Championship meets and Sectional Meets in the spring.
- Harper Lucas reported the second athlete meeting was held over the past month with over 20 athletes attending. The meeting covered camps feedback, mascot development process, champs meets, and junior officials. The committee specifically has recommendations for the champs meets including hot heats and themes for the meets.

## **NEW BUSINESS**

- Amy has drafted a proposal to have an LSC Mascot contest. Submission deadline is December 2, 2025. Anyone in the LSC can submit. The athletes have been briefed and are fully supportive of the proposal.
- January 4, 2025 Board Retreat will be at the YMCA of the Triangle Corporate
  Headquarters from 10am-3pm to include a working lunch. The Board will have a
  directors meeting from 3pm-4pm to take any action at the conclusion of the retreat.
  Board members are encouraged to bring any ideas of topics to be discussed to Amy or
  John. Amy will send out a pole to gather ideas and get a sense of what Board members
  will want to do at the retreat.
- April 12-13 Spring Splash. A technical meeting to review future meet bids will be needed in addition to any other meetings that may be needed to discuss other topics. If a committee or group would like to have a meeting please contact Amy who is working with visit Charlotte to meet our space needs.
- Fall HOD is still TBA.
- NCS has been updating our financial processes. Part of this update is the
  implementation of Bill.com to streamline accounts payable and accounts receivable.
  The newest addition is the recent hiring of a Bookkeeper, Stacy Snapper. The position
  will not be a Board member however she will be joining USAS as a non-athlete
  member. Special thanks to Jon Fox who has led the LSC with our financial processes
  for a long time and then more recently Amy who has put significant time into ensuring
  the LSC finance process has moved forward.
- The Pool Party Sanctioning is still a work in progress with the goal to have everything in place including a sanction request form for January 2025.
